Agreement

ASSOCIATION FOR LIBRARY AND INFORMATION SCIENCE EDUCATION

(hereinafter called the Publisher) and the above-referenced Author hereby enter into the following Agreement in respect to the above referenced Work.

- _____ 1. In consideration for the publication of the Work by the Publisher in the above-referenced Journal, Author hereby grants and assigns to Publisher all rights, title, and interest in and to the Work and all copyrights therein or relating thereto including the right to renew. Author understands and acknowledges that Author will receive no royalty or other monetary compensation from the Publisher or its designees for the assignment made hereunder and the subsequent use of Author's work by the Publisher or its designees. Author further understands and agrees that the Publisher has the right to edit or otherwise modify the Work as it sees fit, create derivative works based on the Work, and publish the Work in any media or format that it chooses. Author also agrees to permit the Publisher to use Author's name and likeness in promoting the work, provided that Author shall have the right to prior review and approval of any such use.
- _____ 2. Publisher hereby grants to Author a royalty-free limited license with rights as specified below, to the Work of which the Author is the author or editor, provided the Work is identified as having first been published in the Journal and that a notation be made with each use that the copyright to the Work is owned by Publisher:

- The right to use all or part of the material contained in the Work in a book by the Author, or in a collection of the Author's work;
- The right to use and distribute the Work internally at the Author's place of employment, and for promotional and any other non-commercial purposes;
- The right to deposit and distribute the Work in an open access archive, or on their individual or institutional Web sites.
