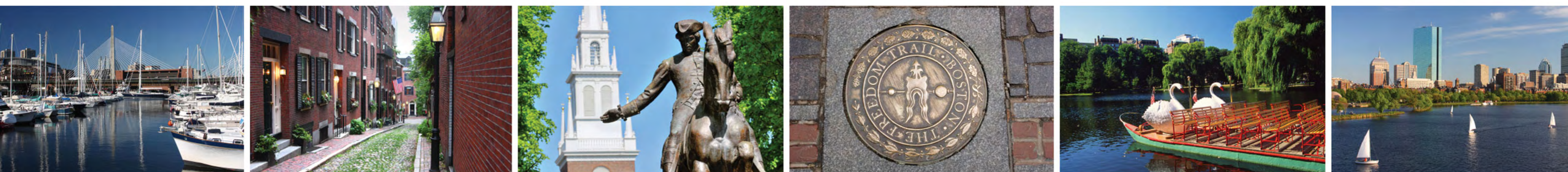

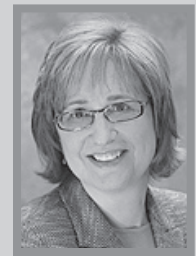

The Future of Collaboration

Thomas Malone, Patrick J. McGovern Professor of Management, MIT Sloan School of Management

New information technologies are enabling profound changes in the ways people collaborate. This talk will explore what these new forms of collaboration will look like. For instance, the talk will suggest that we are in the early stages of a dramatic increase in human freedom in business that may, in the long run, be as important a change for businesses as the change to democracies was for governments. To take advantage of these possibilities we need to invent new—more decentralized—ways of collaborating, including loose hierarchies, democracies, markets, and many other forms of crowd-based collective intelligence.

For two decades, **Thomas Malone** has been a visionary proponent of new organizational designs that take maximum advantage of information technology's expanding possibilities. He is the author of *The Future of Work*, a landmark exploration of the company of the future.

Tom also is the founding director of MIT's Center for Collective Intelligence (CCI), formed in 2006 to study how new communication technologies—especially the Internet—now allow huge numbers of people all over the globe to work together in new ways.

Thomas Malone is Patrick J. McGovern Professor of Information Systems at MIT's Sloan School of Management. He was the founding director of MIT's Initiative on *Inventing the Organizations of the 21st Century* and of the MIT Center for Coordination Science.

He has co-founded three software companies and was a former research scientist at Xerox Palo Alto Research Center. An inventor with two patents, Professor Malone has published over fifty articles, research papers and book chapters. He is co-editor of *Inventing the Organizations of the 21st Century*.

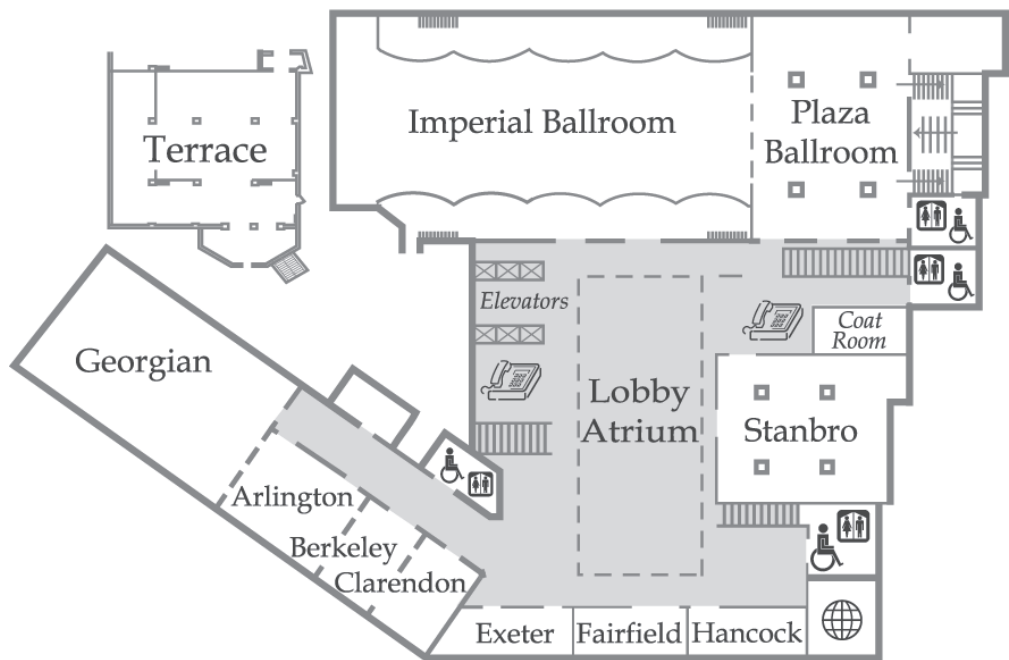
